COUNTRY

We have determined which country to report activity under by looking at country of tax residence of the entity in question and considered other factors such as the location of management and employees and the jurisdiction in which the majority of the entity's revenues are generated. For the purposes of this report, the turnover and loss before tax of IG Markets China (Representative Office) have been included within the figures reported for the UK. No personnel were employed by the representative office during the year. IG Finance 9 Limited, IG Nominees Limited and IG Markets Limited - South Africa Branch are non-trading entities which had no activity to disclose for 2020, and are therefore excluded from the Country by Country Report on page 1.

NUMBER OF EMPLOYEES

This column shows the calculated average number of the monthly employees. IG Markets Limited, and any branches with no employees, are managed by employees of other group companies, or the branch has ceased trading.

TURNOVER

Turnover is the net trading revenue of each entity or branch. The figure gives an indication of the size of the business in each country. The Polish branch turnover includes non-trading transfer pricing income which is not considered as turnover in the IG Markets financial statements and is eliminated on consolidation.

PROFIT BEFORE TAX

These numbers are accounting profits. As with the turnover figures, these numbers include some double counting which has been eliminated on consolidation.

CASH TAX PAID

This column shows the total corporation tax actually paid in each country in the year ended 31 May 2020. Most of the taxes paid in any given year will not relate directly to the profits earned in that year, and negative figures represent a net tax refund received.

DESCRIPTION OF ACTIVITIES

We are also required to publish the nature of the activities in each country and have classified the activities as OTC leveraged derivatives, share dealing, investments, marketing and sales support, holding company, back office and non - trading.

DEVELOPMENTS

In October 2019, IG Index Limited entered into an agreement with a fellow group company, IG Europe GmbH, to cease marketing OTC leveraged derivatives to new clients in the EEA and to transfer part of its business relating to EEA clients. There was no transfer of employees under this agreement.
